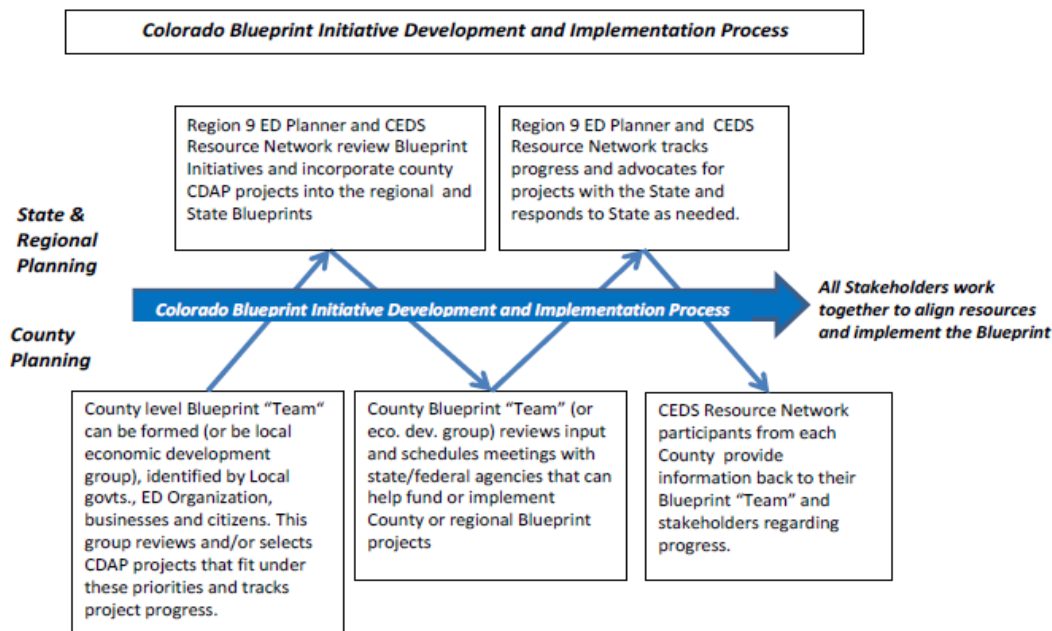

The CDAP also provides a column for each County's Board of Commissioners to rank each project as a "high, medium or low" priority rather than providing more specific prioritization and time frames. The reasons include:

- Even a low priority project will be completed before a high priority one if funding is available.
- Projects get behind schedule.
- Listing specific timeframes cause the CDAP to quickly look inaccurate and not be utilized.
- Listing specific timeframes requires too much guesswork.
- Listing a project on the CDAP is a way to make it a community priority.

Integration of Blueprint Priorities

As part of the Colorado Blueprint process each county in the State chose their top five economic development objectives, which were rolled into regional plans, and then into the State Blueprint.

While not every project in the following county CDAPs met all state and regional objectives of the Colorado Blueprint, nor should they, we found that a number of them meet one or more. We have included a key to illustrate which goals are supported at the local, regional and/or state level. Numeric value does not indicate priority, each goal is ranked equally.
